

## **PRIVATE PARTY SPACE RENTAL AGREEMENT, & REGULATIONS**

All private party renters and their guest must comply with all of the policies and procedures of Fairies and Dragons Parties, LLC a California limited liability company. The policies, procedures, and agreement may be amended at the Fairies and Dragons Parties sole discretion.

1. Any rental of the space for a private party must leave a deposit of **\$ 75.00** in advance to securely hold the desired date and the balance must be paid in full at the end of the scheduled party time. If the party goes over the scheduled rental time the client will be charged an additional time at **\$75.00** per half hour without pro-rating.

2. **Gratuity.** A 15% gratuity will be automatically added to the total of the party of up to 20 children and 20 % for parties of 20 and over children.

3. **Damage and cleaning.** Any excessive damage done to the Fairies and Dragons Parties facility or property shall be billed to the client for either replacement or repair.

a. Any excessive mess (at the determination of the staff) done by children or adults resulting in extra cleaning of the facility shall be charged an additional cleaning fee of **\$100.00**.

4. **Personal Property.** Fairies and Dragons Parties is not responsible for the clients or their guest's personal property. It is the sole responsibility of each person entering the facility to be responsible for all belongings. Under no circumstances will Fairies and Dragons Parties take responsibility for any lost, missing or stolen property personal or otherwise.

5. **Safety.** Parents of children of the invited guest are completely responsible for the well being and behavior of their minor while on the premises of Fairies and Dragons Parties.

6. **Conduct.** Any child or adult during the duration of the party is found to be destructive and/or abusive to the facility will be asked to leave the premises.

### **7. Cancellations:**

Deposit is non refundable

Cancellations made less than 14 days - \$200 cancellation fee

Less than 7 days – full cost of the party

**Arbitration:** Any dispute or Claim arising under or with respect to the Agreement will be resolved by binding arbitration in Los Angeles, California and shall be administered by, and pursuant to, the Commercial Arbitration Rules of the American Arbitration Association before a single neutral arbitrator. Only direct damages may be awarded. No indirect, consequential or punitive damages, lost profits or attorneys fees may be awarded. The award shall be final and binding upon the parties. Any award may be entered as a judgment or order in any court competent jurisdiction.

***These policies shall be governed by and construed in accordance with the laws of the State of California.***
